• ELIGIBILITY OF ADMISSION IN LL.B. (THREE YEARS)

1. To get admission in LL.B. (Three Years) a candidate must have passed 10+2+3 examination from any recognized University of India with minimum 45% marks for General & 42% marks for OBC & 40% Marks for SC/ST candidates.

2. Candidates of other states need to submit character/Domicile Certificate.

3. After getting admission a candidates must secure 75% of class attendance as per regulation of Bar Council of India & Lucknow University.

4. There is no upper age limit for admission in LL.B. (Three Years)

5. Law College has following rights:-

(a) Admission may be cancelled at any time by giving the valid reason.

(b) To amend rule & regulation of admission of college.

(c) Decision of Principal is final admission.

(d) Candidates serving in public/private sector must submit N.O.C. from their respective department.

Regulation of LL.B. (Three Year) Course Certified By University of Lucknow

1. A candidate will be eligible for admission to LL.B. class; if he/she has obtained bachelor's degree recognized by any University with 10+2+3 system and has secured not less than 45% marks for General, 42% marks for OBC & 40% marks for SC/ST candidates at graduation level.
2. As per the ordinance for Admission to LL.B. class (Three Years) from the session 2002-03 and onwards, issued by the University of Lucknow, 80% of the sanctioned seats be filled up from the candidates passing graduation examination from Lucknow University, For the remaining 20% seats are available for admission for Graduate of other University. Any Seat remaining vacant shall be filled with graduates of Lucknow University in order of merit.
3. If the marks obtained in the Graduation examination of two or more candidates are the same, in that case the percentage of marks secured by the candidates at the intermediate examination will be the determining factor of merit for admission.
4. If the marks obtained at the High School or equivalent examination by two or more Candidates are same, in that case the candidate senior in age will get reference in the merit list.
5. Period in between the year of passing qualifying examination and the year of application for admission to LL.B. class shall be treated as gap and 02% marks shall be deducted for each gap year from the percentage of qualifying degree.
6. For a candidate passing Post-Graduate Examination in continuation of the qualifying examination, the time of Post Graduate Examination of two years will not treated as gap.
7. As per Bar Council of India (Part V), Section B (3) the students are required to put in a minimum attendance of 66% in all subjects.

Note: (a) Each registered student shall have completed minimum of 12 weeks internship for Three Year Course stream and 20 weeks in case of Five Year Course stream during the entire period of legal studies under NGO, Trial and Appellate Advocates, Judiciary, Legal Regulatory authorities, Legislatures and Parliament, Other Legal Functionaries, Market Institutions, Law Firms, Companies, Local Self Government and other such bodies as the University shall stipulate, where law is practiced either in action or in dispute resolution or in management. Provided that internship in any year cannot be for a continuous period of more than Four Weeks and all students shall at least gone through once in the Entire academic period with Trial and Appellate Advocates.

(b) Each student shall keep Internship diary in such form as may be stipulated by the University concerned and the same shall be evaluated by the Guide in Internship and also a Core Faculty member of the staff each time. The total mark shall be assessed in the Final Semester of the course.



Nature and Scheme of LL.B. (Honours) 5 Year Integrated Programme



This course is approved and recognized by Bar Council of India Rules under sections 7 (h) and (1) 24(1) (e) (iii-a) 49 (1) (1), and (d) of the Advocate Act, 1961.

It is a combination of B.A. and LL.B. Course. Its Purpose is to educate and train candidates for taking up legal profession and pursue other avenues wherein law subjects are either compulsory or optional. The entire course is appeared over 10 Semesters, each of six months, generally starting on 1st July and 1st Jan. It has been divided up to two parts as follows.

**Part-I 2 Year core programme of pre-law students; and
Part-II 3 Year Programme for professional training in law.**

ELIGIBILITY AND CRITERIA FOR ADMISSION

This course is open to those who have passed intermediate or equivalent (10+2 or 11+1) examination from any recognized Board with minimum given % of marks as decided by the University/Bar council of India. Candidates shall be admitted on the basis of merit which shall be judged by their performance in the qualifying examination and also on the result of test and interview held by the admission committee of the college.

Rule 6(1) of part IV of the Bar Council Rules down the following "The Part-I Examination should be conducted as to be called University Examination. A student who has passed Part-I of the law course shall be eligible for enrolment in the 5 year integrated programme. A student who has completed three years of the 5 year course in Law is eligible to get a degree from the University on passing such examination on conducted by the same University which is equivalent to B.A. (Law) but such degree shall not entitle the student to be enrolled as an Advocate. The enrollment will be possible **after completing remaining two year course, which includes practical training also**".

Note: (a) Each registered student shall have completed minimum of 12 weeks internship for Three Year Course stream and 20 weeks in case of Five Year Course stream during the entire period of legal studies under NGO, Trial and Appellate Advocates, Judiciary, Legal Regulatory authorities, Legislatures and Parliament, Other Legal Functionaries, Market Institutions, Law Firms, Companies, Local Self Government and other such bodies as the University shall stipulate, where law is practiced either in action or in dispute resolution or in management. Provided that internship in any year cannot be for a continuous period of more than Four Weeks and all students shall at least gone through once in the Entire academic period with Trial and Appellate Advocates.

(b) Each student shall keep Internship diary in such form as may be stipulated by the University concerned and the same shall be evaluated by the Guide in Internship and also a Core Faculty member of the staff each time. The total mark shall be assessed in the Final Semester of the course.

HOURS OF STUDY

Teaching, including tutorials, lectures and clinical studies shall be for 5 hours per day. Class room lectures shall not be less than 24 hours per week. for each prescribed paper there shall be lecture classes for three hours and one hour of tutorial work per week.

ATTENDANCE

Every student shall be required to put in minimum attendance of 75% of lectures in each of the subjects as also at tutorials, moot courts and practical training course.

EXAMINATION

The examination shall ordinarily be held at the end of every semester. Suitable of subjects for the period of one year or six months, as the case may be, shall be made by the university, and will be intimated to the 'Bar Council'. The students are advised not to bring any books/notes/mobile to college during the examination period.

LIBRARY

The college has a rich and growing library under the charge of qualified librarians. Adequate number of law books, national and international law journals available there. It remains open for use by the students for about 7 hours every day.



HOSTEL

Only limited hostel facility is at present available for girls. Private accommodation is available both for boy and girls.

TRANSPORT

Limited college transport is available on main route.

OTHER FACILITIES

The College has well equipped computer lab and other scientific laboratories which can be used by students. It is also proposed to give special training to the students in English speaking and other languages on reasonable charges so that they may secure placement elsewhere also. The legal aid clinic will provide training to the students in entire working of Law with the help of professional senior lawyers and experts. It would also provide free help to the poor, destitute and needy sections of the society. Arrangements are also being made to give special coaching to senior students of the faculty so that they may take up legal and judicial service competitions after completing their course.

MEDICAL

A Medical room with the basic facilities including a dental chair, a physician and visiting specialists are available.

PAYMENT OF FEES

Fees due for each semester are to be paid in time by given dates. If fee is not paid by that date, late payment fee shall be charged. Name of the student shall be struck off, if fee is not paid by the last day of the month by which the payment is due. He/She shall be allowed for re-admission on payment of arrears including tuition fee and late payment fee.

RULES AND REGULATIONS

The college shall run according to the rules of 'Bar Council of India' and 'Lucknow University' Under Self Financing Scheme.

DISCIPLINE

The College lays full emphasis upon discipline, Students are expected to follow all rules and regulations.

They are not permitted to leave the campus during college hours without the permission of the Manager/Principal.

If any students indulge in any act of indiscipline, he/she shall incur the risk of rustication. The verdict of the Manager/Principal regarding punishment is final. Use of mobile phones are forbidden in the college.

UNIFORM

Uniform is compulsory for all students. They are not permitted to enter the college campus without uniform. The details are as follows:

SUMMER

1. Boy : Black Pant, White Shirt, College Tie, Belt, Black shoes and black socks.
2. Girls : Black Pant, White Shirt, College Tie, Belt, Black shoes and black socks.

WINTER

1. Boy : Black Pant, White Shirt, College Tie, Belt, Black shoes and black socks and black sweater/blazer/black coat.
2. Girl : Black Pant, White Shirt, College Tie, Belt, Black shoes and black socks and black sweater/blazer/black coat.

Important Rules of Admission in Law College

1. Admission brochure of college is fully authorized by act & regulation, ordinances & Statute of Lucknow University.
2. Cost of the Brochure is Rs. 500/- which can be obtained by paying in cash at the fee counter of Law College?
3. Timing of Law College is 09:00 a.m. to 03:00 p.m. on all working days (Monday to Saturday).
4. Candidates seeking reservation & weight age must attach relevant documents issued by competent authorities.
5. All the documents related to educational qualification & certificates must be enclosed with admission form.
6. Candidates are instructed to participate in all the Co-curricular & Extra-curricular activities organized by Law College.
7. Admission fee deposited at the time of admission shall not be refunded in any case.

5. Transfer Certificate is mandatory. (For LL.B. 5 Years Programme)
6. N.O.C. from parent department if serving in state/central Govt.
7. Caste certificate/Income certificate/Domicile for claiming fee reimbursement /scholarship.
